

This is the sale of one Olde English Bulldogge puppy. This puppy is registered with the IOEBA (International Olde English Bulldogge Association). The sire of the litter is _____ and the dam is _____. The price of the puppy is _____ Plus shipping if needed, which is at the sole expense and arrangement of the buyer. This puppy will be ready to go to his/her new home at 8 to 10 weeks of age after the puppy has received his required vaccinations and worming.

Commitments of Buyer and Seller: (Buyer to initial each item)

The buyer agrees to register with the IOEBA and must use "Phoenix's Blue" as the producer of the puppy as the prefix to the registered name of the dog. For example, if the dogs name is to be "Spot", then the registered name could be "Phoenix's Blue Spot".

A Five hundred dollar (\$500) non-refundable deposit is required to hold a puppy.

Puppy picks must be paid for by the 6th week of age.

You can pick up your puppy after the eighth (8th) week of age when the worming and vaccinations are complete. If the puppy is to be shipped, shipping will occur after the eighth (8th) week of age. The puppy must be paid for in full in American dollars prior to the release of the puppy to the buyer.

Your puppy must be picked up by the tenth (10th) week of age or there will be a \$100 per week charge for boarding the puppy beginning at the 8th week.

This puppy is not to be bred. The puppy is being sold with a **spay/neuter contract and limited IOEBA Registration.**

This puppy is being sold with **full breeding rights and full IOEBA registration papers.**

If this puppy is being sold with **limited registration then they buyer is required to have the puppy spayed or neutered by the age of 6 months.** When proof is provided to seller, registration papers will be provided.

You commit to having your puppy vaccinated by a licensed veterinarian of your choice with the rabies vaccination by the sixth (6th) month of age at the very latest. Your puppy will receive the appropriate vaccines at age 6 weeks and 8 weeks of age. Vaccination schedule thereafter is per your veterinarian's typical protocol, so it is necessary to follow

up with your veterinarian after the initial exam. The protocol after 8 weeks is up to you and your vet. Failure to continue to vaccinate your puppy can be fatal and would be the absolute fault of the buyer. Phoenix's Blue Olde English Bulldogges will not replace the puppy or sell another puppy to the buyer if the puppy should die of a disease that he/she was not properly vaccinated.

You also commit to taking care of your dog by making sure that it is properly vaccinated, fed, watered and housed. Bulldogges do require additional care that is essential to their well-being. For example, facial wrinkles require washing and drying which should be done on regular basis, several times a week.

Although the Olde English Bulldogge is a healthy alternative to the traditional English Bulldog and much healthier, no Phoenix's Blue OEB will be chained/tied outside. If any Phoenix's Blue OEB is found to be kept solely outdoors, subjected to long periods of exposure to extreme heat, "chained up" or found to be abused or neglected in any way whatsoever, the sale is void and the dog will be returned immediately to Phoenix's Blue OEB's without refund of any funds whatsoever. No exceptions.

Under NO circumstances will this dog be placed in a shelter or SPCA. If you no longer want the dog for any reason, please give the dog back to us before you dispose of him in a shelter. Our bulldogges are not disposable under any circumstances whatsoever.

The buyer agrees that the dog will not be used for any illegal activity. If found doing so, seller has the right to remove the dog and place with a proper owner without any monies being issued/reimbursed.

Commitments of Buyer and Seller: (Buyer to initial each item)

The puppy you are buying is an F3 Olde English Bulldogge, which will be registered with the IOEBA.

Your puppy is guaranteed to be free of any inheritable disease that causes death or serious impairment of vital functions in the puppy until such puppy is 12 (Twelve) months old. If such an inheritable disease is documented by a licensed veterinarian and presented to the seller with sufficient supporting evidence as determined by Phoenix's Blue Olde English Bulldogges, the buyer will be entitled to a replacement puppy of comparable quality from the current litter, if available or the next available litter which could possibly be a year in the waiting.

The seller reserves the right to a second (2nd) veterinarian's opinion at the expense of the seller and full cooperation of the buyer. In the event that the puppy is proven to have an inheritable disease, the puppy with the disease will be returned to Phoenix's Blue Olde English Bulldogges with the cost of shipping to be shared equally by the seller and buyer. The time that the buyer may have to wait for the next litter may be one year or greater if a planned breeding does not result in a litter. This is beyond the control of the seller, but Phoenix's Blue Olde English Bulldogges will do their very best to find a solution, as quickly as possible to rectify a situation in the event of an inheritable disease. A replacement puppy may also come from a breeding not done by Phoenix's Blue Olde English Bulldogges, but from a stud service done by us in the case that such a puppy is

available. No monies will be returned to the buyer under any circumstances except as specifically mentioned in this document and Phoenix's Blue Olde English Bulldogges does not pay any of the buyer's veterinarian bills whatsoever.

In the event that your puppy dies while in my possession for whatever reason, we will refund all monies you have paid toward the purchase of your puppy minus the deposit. The deposit will be used to guarantee a puppy from a future litter or choice from any current puppies available. This is the only instance that any money will be returned to the potential buyer.

The puppy will be in good physical condition at the time of shipping and joining your family. The buyer agrees to have the puppy examined by a licensed veterinarian, at buyer's choice and expense, within 2 business days after the delivery of the puppy to the buyer for a complete physical examination. If a licensed veterinarian finds the puppy to have a serious physical condition other than common bacterial infections, such as, but not limited to coccidia or giardia or in need of a general worming, which are all easily treated, the seller will replace the puppy with another of comparable or better quality (which may not necessarily be a Phoenix's Blue Olde English Bulldogges puppy and could take up to one year for the next breeding as explained earlier in this document).

The seller reserves the right to a second veterinarian opinion at the seller's choice and expense (but would require complete cooperation of the buyer for the seller to have access to the puppy for this to occur). Puppies are prone to the common bacterial infestations such as giardia and coccidia and Phoenix's Blue Olde English Bulldogges does not guarantee for these. In case of a health condition as above, the Buyer must notify seller within twenty four (24) hours of the diagnosis. If the puppy is not examined by a veterinarian within the required specified period, the above health guarantees are no longer in effect. No monies will be refunded.

Phoenix's Blue Olde English Bulldogges also has the right to refusal at anytime. Any spoken modifications made to this agreement shall be made in writing or such shall not be effective.

By signing below, the buyer and seller agree to the terms set forth in the previous pages. This is a legal binding contract. Any legal action necessary to enforce this contract will take place in Arizona.
